04. The School times, Vacations and mid-term holidays shall be as prescribed by government from time to time.
05. That the qualified staff within the age limits prescribed by the Government for Government Employee shall be appointed as per the staff pattern.
06. That the results of institution shall be satisfactory every year.

07. That the records/accounts shall be furnished to the District Educational Officer every year 31st May at latest.
The Management is informed that as per G.O.Ms.No.1 Education dated: 01-01-1994, the fee collection from the students shall be allocated as to meet the following requirements: -
- 50% of the fees collected shall be earmarked towards payment of salaries to the staff.
 - 15% of fees collected shall be utilized for the maintenance of the institutions towards expenditure involving the building rent, electricity and water charges, stationery office payments to be made to menial and auditors, purchase of Library books, Lab Equipment and Chemicals and expenditure involving the upkeep of the institution etc.
 - 15% of fees collected shall be earmarked for the developmental activities of the institution.
 - 15% of the fees collected shall be earmarked as management's contribution towards staff benefits like gratuity, teachers provident fund, Group insurance scheme etc.
 - 5% of the fees collected shall be earmarked as personal income to the Management.
08. Library should be enriched with at least 1000 books.
09. E.W.F. Scheme should be implemented to all the staff members.
10. That the list of Governing body shall be furnished to the DEO every year.
11. That the pay structure/Fee structure fixed by the governing body shall be got approved by the DEO every year.
12. That all the conditions prescribed in the G.O. and other orders which are not specified in these orders shall be complied with.
13. That the School shall not be closed without giving notice both to the parents/DEO and competent authority at least 6 months before.
14. That the school shall be closed for permitted to be closed only from the date on which summer vacation is declared.
15. That the society shall submit proposals for Renewal of Recognition sufficiently in advance i.e., at least 6 months prior to the date of expiry of the order. However by the end of April every year, the Educational agency shall file an affidavit to the effect that there is no deviation or violation of norms/rules prescribed by the Government from time to time.
16. The Management has to submit the renewed fire certificate to the Regional Joint Director of School Education, Kadapa every year with in the stipulated period.
17. The Management has to submit the Audit Report of the school with audited statement of accounts of every year without fail.
18. That the affidavit as per G.O.Ms.No.41 Edn dt:11.05.2006 should submit in every year

Whereas, in the reference 2nd read above, Recognition has already been granted to **Yasoda E.M School, Puttaparthi Road, Dharmavaram (V&M), Sri Sathya Sai District, Puttaparthi**for classes I to V (EM) in respect of for the academic years from 2022-2023 to 2024-2025 i.e., 03 years.

In the reference 4th read above, the Govt. of Andhra Pradesh has issued orders to extend the recognition for further 05 years which was granted for 03 years earlier for a total period of 08 years in compliance of the orders dt:11/08/2023 of the Hon'ble High Court in W.P.No.18190 of 2023 and the same has been communicated by the Commissioner of School Education, Andhra Pradesh, Amaravathi.

Therefore, the Recognition granted earlier for the years from 2022-2023 to 2024-2025 i.e., 3 years in respect of **Yasoda E.M School, Puttaparthi Road, Dharmavaram (V&M), Sri Sathya Sai District, Puttaparthi**for the classes I to V (EM) is here by extended for further 05 years from 2025-2026 to 2029-2030. The remaining conditions at earlier recognition order prevails same, subject to fulfillment of the following conditions.

1. The Management should submit the annual administration report in the prescribed proforma to the competent authority for every financial year by the 30th September at the latest. Such report shall be supported by the audited statement of accounts of the school duly audited by Chartered Accountant. Separate accounts shall be maintained for each school.
2. That the Management has to renew the Fire certificate, Police No-Objection Certificate from time to time as per rules and submit this office, otherwise the Recognition will be cancelled at any time without any prior notice.
3. That the Management shall provide all safety measures to the students in case of Fire accidents and natural calamities.

4. That the Management should submit an affidavit by the end of April (every year) to effect that there is no deviation or violation of norms & rules in respect of Fire safety measures as prescribed by the Govt.
5. That, the management shall obtain and submit the Structural Soundness certificate and Sanitary certificate every year before reopening of the school for the academic year.
6. That the pay. structure/fee structure fixed by the Governing body shall be got approved by the District Educational Officer, Sri Sathya Sai District every year.
7. That the management shall submit proposals for renewal of recognition sufficiently in advance i.e., 06 months prior to the completion of the academic year.
8. That the Management shall necessarily follow the stipulations envisaged in G.O.Ms.No. 24 SE(PII)Dept. Dated:26.02.2023 & G.O.Ms.No.1 Education, dated: 01-01-1994 and follow the rules prescribed by the Govt. from time to time without fail
9. The Recognition orders will be cancelled / Modified if any objection raised by the higher authorities/Parents/Public (or) if the Management fails to provide the conditions prescribed by the Government.
